 - c) Nationality.

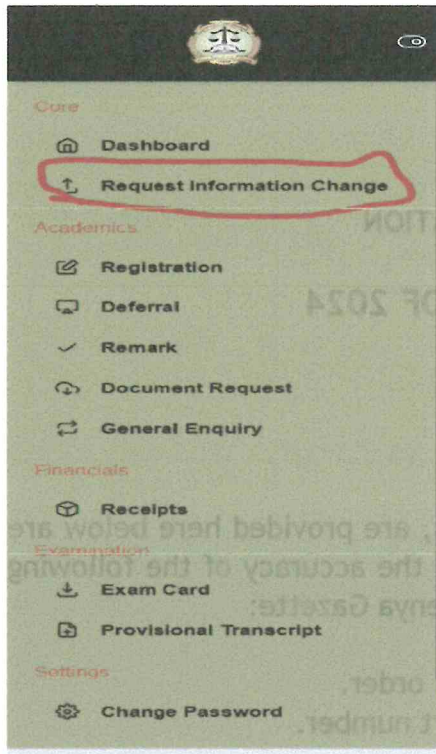
