RELEASE OF THE BAR EXAMINATION RESULTS
APRIL 2025

The Council of Legal Education (CLE) administered the Advocates Training Examination (Bar Examination) between **10th April 2025 to 24th April 2025**.

A total of 1,675 candidates sat for examinations, 270 and 1405 candidates sat as regular and re-sit candidates, respectively. In this examination series, Candidates recorded high scores in Trial Advocacy (ATP 104), Conveyancing (ATP 107), and Civil Litigation (ATP 100), with a pass rate of 93.88%, 73.08 and 69.44% respectively. In comparison with the April 2024 examination, significant improvement has been noted in ATP 107 Conveyancing and ATP 108 Commercial Transaction.

ATP 105 - Professional Ethics and ATP -103 Legal Writing and Drafting declined in performance in this examination series, with the units recording a pass rate of 23.84% and 39.90% respectively.

Overall, the April 2025 examinations reflect a marked improvement in performance compared to those conducted in April 2024.

Tables A and B illustrate the performance of the April 2025 examinations for each unit, in comparison to the April 2024 examination series for regular and re-sit candidates.
