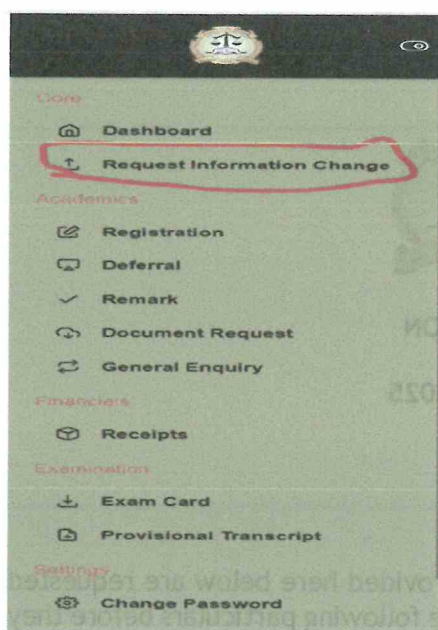
- a) Full name, including spelling and order.
