**CANDIDATES BARRED BY THE FIVE (5) YEAR RULE (APPLICATION FOR
EXTENSION OF TIME)**

Following applications received on or before **28 February 2022** by Council from persons barred from registering for the Advocates Training Programme (ATP) examinations **April 2022 series** due to the “Five-year rule”, this is to inform the general public that Council has reviewed and made determinations on the respective applications. Below is a list of the first batch of successful applicants. Successful candidates are advised to visit the student portal and proceed with registration of April 2022 examination series immediately. The window for registration shall be open for a limited period of **seven (7) calendar days** from the date of this Notice.

Please note that the waiver for extension of time to register and sit for examinations is only valid for **one year** and therefore candidates shall **only be allowed** to register and sit for the **April and October 2022** examination series.

Please further note that the Council has rejected applications from persons who previously attempted examinations under retired ATP curricula and therefore the unsuccessful applicants are advised to seek

fresh registration for admission to the ATP at the Kenya School of Law and fulfil all requirements for registration of examinations under the current curriculum.

The Council will publish the next batch of successful applicants shortly and shall inform each unsuccessful candidates on the outcome of their respective applications.
