To commemorate ten years of existence, the Council of Legal Education (CLE) is organizing a conference under the title "Legal Education and Training in Kenya; past present and future reflections/perspectives"

CALL FOR ABSTRACTS: The Council of Legal Education (CLE) in collaboration with the National Council for Law Reporting (Kenya Law), calls upon contributors who desire to participate as speakers/presenters at the Conference to submit concise abstracts in the following broad thematic areas;-

(i) Interrogating and unpacking legal education and training in the backdrop of shifting domestic and global developments; navigating the dichotomy between domestically oriented but globally competitive legal education and training in policy and curricula;-perspective from the Bench, Bar, academia and sector regulators.

- (ii) Exploring strategies for the progressive development of legal education and training with a view to realizing the goal of the globally competitive but domestically competent practice ready lawyer
- (iii) Demystifying legal skills; conceptualizing suitable legal skills for domestic and global relevance and how best to realize these skills in legal education and training.
- (iv) The future of regulation of legal education and training in Kenya; Scaling up quality standards in legal education and training through enhanced self-regulation by Schools of Law in Kenya.
- (v) Decentralization of legal education and training in Kenya.
- (vi) Regulation of paralegal training and recognition in Kenya

The call is open to all researchers, scholars, legal practitioners, judicial officers and academicians.
