**REGISTRATION FOR MARCH 2023 ADVOCATES TRAINING PROGRAMME
(ATP) EXAMINATION**

IT IS NOTIFIED for general information that registration for the March 2023 Council of Legal Education ATP Examination will commence on Tuesday 3rd January 2023 and close on Tuesday 2nd February 2023.

Candidates are encouraged to register within the specified period to avoid being locked out.

Candidates will be required to register log into <http://exam.cle.or.ke:882/> to access the CLE online registration portal.

The requisite Examination fees are provided for in the Students Guide that can be accessed or downloaded from CLE's website. Examination fee is payable through **Mpesa Paybill No 4060345**. A candidate should **ONLY** make payments after logging into the portal and providing all requisite information and attachments where applicable.


Procedure for registration is provided below as follows.

NB: A Regular candidate applying for registration of the ATP examination must have completed the Oral and Project examination.

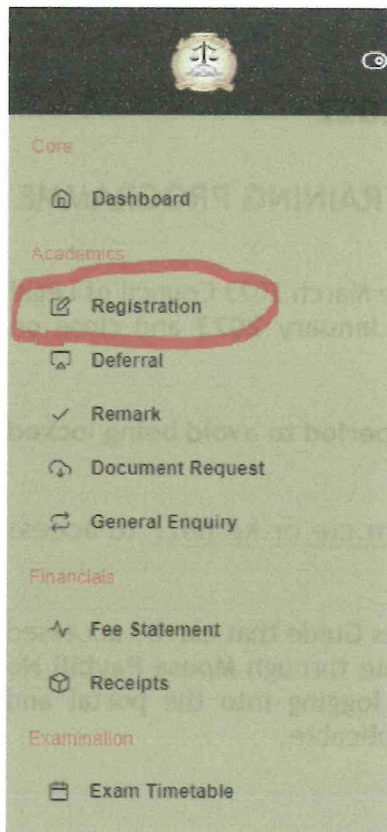

Appendix I: Procedure for registration of candidates who have used the CLE portal previously

Login to the candidate's portal via <http://exam.cle.or.ke:882/> and click on registration as shown below.



You will see your registration summary over the series as shown below
