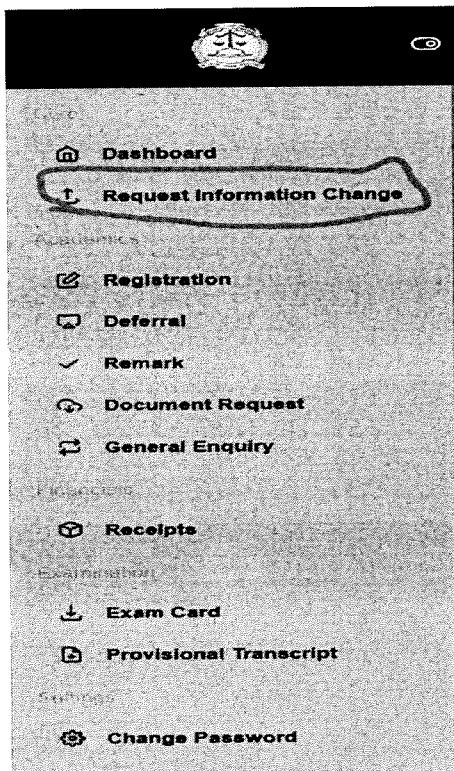
The following candidates are requested to **log into their portal and verify the accuracy of the following details** before they are published in the Kenya Gazette:
