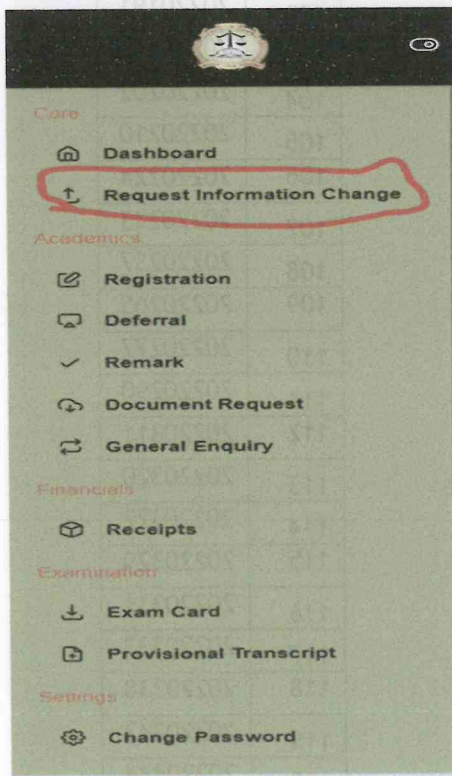
The following candidates are requested to log into their portal and verify the accuracy of the following details before they are published in the Kenya Gazette:
